## Application for Membership

I, the undersigned, hereby make application to request membership of Giles Country Club, agreeing to abide by the rules and regulations thereof, and to pay appropriate membership dues and fees. One Quarters membership dues are attached to this application. Membership includes all services of the Club as listed below. There are some special events that charge an additional fee (i.e. dinners, dances, and golf tournaments). By completing this application, I acknowledge that:

1. No one under the age of 21 may apply for membership.
2. Unmarried applicant's ages 25 or less may request the board for a single membership.
3. Introductory memberships are available to first time members only. Rate converts to full status after one year.
4. Junior memberships are available to persons or married couples between the ages of 21 and 28.
5. All dues are payable in advance of the quarter.
6. Dues may be paid monthly, quarterly, or annually based on the preference of the member.
7. Acceptance of membership is at the discretion of the board of directors. You are granted temporary membership privileges until the GCC board of directors approves your application. (Board of Directors convene once a month)
8. Per the bylaws of the Club, members who resign from the Club during a quarter are obliged for the entire quarter's dues. Your resignation must be stated in writing and submitted to the board of directors in order to be valid. If no written resignation is provided, your dues will continue to accrue until notice is provided to the board of directors. You are obliged to render payment for any delinquent dues at the time of your resignation.

### **Single Membership**

The Single Membership allows members who fulfill the Single Membership requirements unlimited use of all Club facilities within the rules established by the Club. Individuals must legally be defined as single and must be between the ages of 21 and 25. Dues for the starter member are approximately 53% lower than that of a full member.

### **Introductory Membership**

The Introductory Membership (first-time members only) allows members and their immediate family to enjoy unlimited use of all Club facilities within the rules established by the Club. A family is defined as an eligible individual, his or her spouse, and dependent children 21 years and younger living at home or 25 years and younger attending school. A dependent's age on the first day of April shall be used for determining eligibility for the next twelve months. To be eligible for this membership category, applicants can only be first-time members. Anyone that has been a former member of the Club is not eligible under this category. Dues for introductory members are approximately 22% lower than that of a full member.

### **Junior Membership**

The Junior Membership allows members who fulfill the Junior Membership requirements and their immediate family to enjoy unlimited use of all Club facilities within the rules established by the Club. All individuals or family members (not including dependent children) must be between the ages of 21 and 28. A junior member's age on the first day of April shall be used for determining eligibility for the next twelve months. Dues for the junior member are approximately 22% lower than that of a full member.

### **Full Membership**

The Full Membership allows members and their immediate family to enjoy unlimited use of all Club facilities within the rules established by the Club. A family is defined as an eligible individual, his or her spouse, and dependent children 21 years and younger living at home or 25 years and younger attending school. A dependent's age on the first day of April shall be used for determining eligibility for the next twelve months.
